The flag salute was recited.

Mayor Nyland called the meeting to order at 7:02 PM.

Meeting Minutes:

The February 19th, the Township Committee Meeting, Board of Health Meeting and March 4th Budget Meeting were approved on motion by Mr. Norton, seconded by Mrs. Miller and passed unanimously on roll call vote.

Ordinances:

On motion by Mayor Nyland, seconded by Mr. Norton and passed unanimously on roll call vote to table <u>Ordinance 2020-01-Creating Cat Licenses</u> until the May 20, 2020 Township Meeting.

<u>Ordinance 2020-06</u> Amend CAP Ordinance was read by title on second reading and opened for public comments.

There were no public comments.

RESOLUTION 2020-34

RESOLUTION AUTHORIZING THE TOWNSHIP OF OXFORD TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED TAX BILLS IN ACCORDANCE WITH P.L. 1994, c.72

WHEREAS, the Warren County Board of Taxation has not adopted the Warren County Budget for 2020, and the Township of Oxford Tax Collector will be unable to mail the Township's 2020 tax bills on a timely basis,

WHEREAS, the Township of Oxford Tax Collector/Chief Finance Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and has signed a certification showing the tax levies for the previous year, the tax range and the range of permitted estimated tax levies:

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF OXFORD, IN THE COUNTY OF WARREN, AND STATE OF NEW JERSEY ON THE 16th OF APRIL, 2020, AS FOLLOWS:

- 1. The Oxford Township Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the Township for the third installment of 2020 taxes. The Tax Collector shall proceed on April 16, 2020 and take such actions as are permitted and required by P.L. 1994, c.72 (N.J.S.A. 54:4-66.2 and 54:4-66.3.
- 2. The entire regular estimated tax levy for 2020 is hereby set at \$6,668,012.71
- 3. In accordance with law the third installment of 2020 taxes shall not be subject to interest until the later of August 10 or the twenty-fifth calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.

RESOLUTION 2020-35

SELF-EXAMINATION OF BUDGET

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted

to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the *Township of Oxford* has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2020 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the *Township of Oxford* that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

On motion by Mayor Nyland, seconded by Mr. Norton and passed unanimously on roll call vote to adopt **Resolution 2020-37.**

On motion by Mayor Nyland, seconded by Mrs. Miller and passed unanimously on roll call vote to sign and approve the Phoenix Advisors contract.

Township Committee Reports and Correspondences:

Mr. Norton stated that he received a letter from Dr, Tolentino asking to waive the sewer fee at a house that he just purchased.

Ms. Oberly stated that in the past the Committee has not waived this fee unless there was a fire or some catastrophe happened that there was no water connected to the house.

The Committee stated that they will discuss this further after additional research.

Mr. Lavery said that he reviewed the Township's ordinance and there is no verbiage that states the sewer fee can be waived. He will send the Committee a copy.

Mayor Nyland stated that James Williams has submitted a bid of \$1,500.00 for Block 1.01, Lot 24, township owned property adjacent to his house. He asked that Mayor Nyland have the homeless removed from the site. Mayor Nyland will follow-up with Tom Cicerelle, Chief of Police and Alex Lazorisak, Warren County Administrator.

On motion by Mr. Norton, seconded by Mrs. Miller and passed unanimously on roll call vote to accept the bid of \$1,500.00 for Block 1.01, Lot 24.

Mayor Nyland asked that everyone "Social Distance." He stated that the Oxford Furnace Lake is open to fishing but must follow the rules and wear masks and keep ten feet apart.

He asked that everyone pray for the nursing homes since this is a big concern with the Coronavirus being spread to the residents.

Mrs. Miller stated that the Coordinators are holding "Make a Mask" Contest. There will be three gift cards offered-\$25.00, \$15.00 and \$10.00 and will be judged on Creativity and the Total Amount made. Also, the Coordinators are discussing "Decorate a Door" Contest.

Mrs. Miller said that the Coordinators are also working on events that can be held at the Lake when this pandemic is over.

Mr. Norton stated that the pump needs to be replaced at the Vista Rossi pump station. One quote has been received for \$11,600.00 and Matt Hall is soliciting additional quotes.

Mr. Norton informed everyone that he attended the Oxford Central School Board Meeting and the Board of Education has decided not to put the referendum question on the General Election ballot this year.

Mayor Nyland stated that the Municipal Building needs a new phone system (VPN) and firewall that will be more refined, get data and voice messages up to date and will cut down on monthly bills.

Matt Hall said that he has submitted the LEAP resolutions, which has been extended. This grant would go toward the purchase of new phones.

He stated that a COVID-19-line item has been added to the 2020 Budget and he will keep track of any and all expenses and hopefully get reimbursed from FEMA.

Township Engineer:

Mr. Finelli stated the following:

- Kauffman Drive, Section #2, Moving along-Tilcon, hopefully will be paving next month and job should be done by Memorial Day
- 2021-NJDOT Application is due July 1, 2020-Will Coordinate with the Committee for a Good Candidate
- Oxwall-Correspondences from Jeff Magdon for Phase 3-Various Tasks to be Done-Clean-up-Solicit bids from Contractors to do Work, Check the HDSRF Application

Mr. Finelli suggested the following:

- Bid up Front Work before filing application (Cost: About \$5,000.00)
- Up Front Investment-Chunk of Change
- Wait till Covid-19 is Over to Move Forward
- Start Thinking of Selling Property

Mr. Finelli said he talked to Jeff Magdon and the Property can be sold. If the price for example to clean-up is \$200,000.00, deduct from the price and get the property back on the tax rolls.

Mr. Finelli stated that Mr. Magdon has not done anything with the property since Phase II.

Mr. Norton will call Mr. Lavery tomorrow to discuss OxWall.

Mr. Lavery stated that the Solar Bids have been advertised and are due April 28th by 10:00 AM.
