ORDINANCE 2017-01

CALENDAR YEAR 2017

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township of Oxford in the County of Warren finds it advisable and necessary to increase its CY 2017 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Oxford Township Committee hereby determines that a 3.0% increase in the budget for said year, amounting to \$53,016.90 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Oxford Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Oxford Township Committee of the Township of Oxford in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Township of Oxford shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$61,853.05, and that the CY 2017 municipal budget for the Township of Oxford be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

On motion by Mr. Pasquini and seconded by Mr. Nyland to adopt on first reading, <u>Ordinance</u> <u>2017-01</u> Exceed the Municipal Budget Appropriation Limits and to Establish a CAP Bank.

ORDINANCE 2017-02

AN ORDINANCE APPROPRIATING THE SUM OF UP TO\$2,000.00 CURRENTLY LOCATED WITHIN THE CAPITAL IMPROVEMENT FUND OF THE TOWNSHIP OF OXFORD FOR COMPUTER EQUIPMENT AND SETUP

WHEREAS, there are currently funds, raised by the Current and previous, budgets within the Capital Improvement Fund of Oxford Township, and

WHEREAS, it is deemed appropriate to make use of up to \$2,000.00 of the allowable Capital improvements for Computer Equipment

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Oxford, County of Warren, State of New Jersey, as follows:

- Section 1. The sum of up to \$2,000.00 presently located in the Capital Improvement Fund is hereby appropriated for Computer Equipment and Set-up.
- Section 2. In connection with the amount authorized in Section 1 hereof, the Township Committee makes the following determinations.
 - A) The purpose described in. Section 1 hereof is not a Current Expense and is an improvement which the Township may lawfully take as a general capital improvement
 - B) The period of usefulness of the purpose described in Section 1 hereof is not in the limitation of the Local Bond Law and the reasonable life thereof is at least five (5) years.
- Section 3. All ordinances or parts of ordinances which are inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.
- Section 4. This ordinance shall take effect immediately after final passage, approval and publication as provided by law.

On motion by Mr. Pasquini and seconded by Mr. Nyland to adopt on first reading, <u>Ordinance</u> <u>2017-02</u> Appropriating the Sum of up to \$2,000.00 from the Capital Improvement Fund for Computer Equipment and Set-up.

New Business:

Kathryn Windsor from Verizon Wireless attended the meeting to explain that Verizon Wireless is in the process of planning to upgrade and enhance its network by deploying small network nodes in the public right of way. Part of the planning process includes securing the permission necessary for that deployment. Verizon Wireless would like to receive non-site specific consent granting permission to locate and operate in the right-of-way in Oxford Township by attaching to existing and new utility poles, and would later obtain any required site specific consents for each node through the Building Department.

As such Verizon Wireless is requesting consent from the Township Committee to use facilities lawfully erected in the public right-of-way for small network nodes.

Ms. Windsor submitted a fact sheet with details of the proposal, and relevant statutes for reference.

On motion by Mr. Pasquini, seconded by Mr. Nyland and passed unanimously on roll call vote to open and amend the Teamsters Local Union No 469, Department of Public Works Contract.

On motion by Mr. Pasquini, seconded by Mr. Nyland and passed unanimously on roll call vote to approve and authorize Mayor Ryan sign the Warren County Mosquito Control Commission contract.

Ken Dunham of Smart Recovery attended the meeting to thank the Committee for allowing his group to use the downstairs once a week, every Thursday from 6:00 PM to 7:30 PM. He stated that the meetings have been well attended and in the month of November, new people have joined the group. Mr. Dunham said that everyone knows someone struggling with addiction – gambling, sex, food, alcohol, drugs, reading novels, etc. Help is out there-Think Rationally-"I Can Do This!"

The Committee discussed hiring a Lake Director for Oxford Furnace Lake to six month position-April through October.

On motion by Mr. Pasquini, seconded by Mr. Nyland and passed unanimously on roll call vote to advertise for all positions, (Lifeguards and Lake Director) in February. Mayor Ryan will write the ad to be advertised.

Mr. Pasquini stated that Tilcon has offered to donate \$7,500.00 and Covanta \$2,000.00 to be put towards the "Welcome to Oxford Sign."

Nick Guarriello asked if there was a decision by the Committee on the proposal they submitted in December asking for 100 houses instead of 325 houses to be built on the Oxford Textile site. Mr. Guarriello also asked if Todd Poole has received the new proposal.

Mayor Ryan stated that no decision has been made and that the Committee is looking at all sites in Oxford Township.

On motion by Mr. Pasquini, seconded by Mr. Nyland and passed unanimously on roll call vote to schedule a Workshop meeting on February 8th to discuss Oxford Textile.

Mr. Nyland stated that JCP&L are changing street lights to LED because it is cheaper. Mr. Nyland suggested that the Township look into solar power to reduce the Township's electric bill.

Mayor Ryan stated that there is a budget meeting on February 22nd at 4:00 PM in the Oxford Municipal Building and will find out at the meeting how the Township did in 2016.

Mr. Finelli suggested that possibly a grant could be found to resurface Snyder's Lane. He said in his opinion, he didn't think NJDOT would approve this street as a grant recipient.

Peg Hissim thanked the Oxford Road Dept. for helping the Emergency Squad.

Mrs. Fredenzi stated that her daughter Alexandria Fredenzi, student at The University of West Virginia has put the link oxfordtwpnj.org on the township website and it will be on the Township's face book too. She asked that if anyone is interested, to please put your name on the list in the back of the room.

Mr. Ryan will review and approve all information to be posted to the website and the face book page.

Becky Roberts said that baseball is now through Warren Hills and asked if they could have permission to use Wilkinson's field, to extend the field to senior leagues, with no cost to the Township. She stated that the League will pay for any construction cost on the field.

On motion by Mr. Pasquini, seconded by Mr. Nyland and passed unanimously on roll call vote to allow Warren Hill's baseball team to use Wilkinson's Field.
