## TOWNSHIP MEETING MAY 16, 2018

The regularly scheduled meeting of the Mayor and Committee of the Township of Oxford was held on May16, 2018 in the Township Municipal Building, at 11 Green Street, Oxford, New Jersey.

In attendance were Robert Nyland, Bill Ryan, Michael Finelli, Michael Lavery and Sheila L. Oberly. Doug Ort arrived 7:15 PM

The flag salute was recited.

Mayor Nyland called the meeting to order at 7:00 PM.

Anthony Ardito, Auditor attended the meeting and gave a short synopsis of the 2018 Operating Budget. He stated that this year it was tough because of the additional items added to the budgetbonding a new ambulance, extra \$25,000.00 appropriated to the Oxford Fire Department and adding \$10,000.00 to the Salt Trust. Mr. Ardito stated that property taxes would increase 1.4 cents, which could cost a property owner an estimated \$23.00 per year.

Mr. Ardito explained to keep taxes down, money was taken out of the Sewer Surplus to fund the 2018 current fund budget.

The meeting was open for public comment on the 2018 Budget.

There being no public comment, the public comment on the 2018 Budget was closed.

On motion by Mr. Ryan and seconded by Mayor Nyland to adopt the 2018 Budget.

# **Unemployment Trust**

# New Business:

The Committee reviewed the Washington Township Shared Service Agreement for the Animal Control Officer and on motion by Mayor Nyland, seconded by Mr. Ryan and passed unanimously on roll call vote to sign the ACO Shared Service Agreement.

The Committee received a letter from the Oxford Land Use Board stating that at their April 24<sup>th</sup> meeting, the board reviewed Ordinance 2018-09 and found no provisions of the ordinance inconsistent with the Masterplan.

Mayor Nyland said he reviewed the price of constructing the "Welcome to Oxford" sign and would like to impose an annual fee to the business owners that have their business listed on the sign. He also stated a fee will be charged to anyone that wants to add their name to the sign.

On motion by Mr. Ryan, seconded by Mayor Nyland and passed unanimously on roll call vote to charge a fee of \$100.00 a year in order to pay for the upkeep (taking care of the sign, planting

flowers, etc.) to business owners listed on the sign, and charge new business owners \$75.00 to add their business to the sign.

On motion by Mayor Nyland, seconded by Mr. Ryan and passed unanimously on roll call vote to hire the following lifeguards to work at Oxford Furnace Lake in 2018:

Justine Lewis AJ Lewis Kara Tipton Nicole Williams Molly Burton Brian Spolarich Danielle Mikaliunas

The discussion to receive proposed incentives for the lifeguards at the end of the season was tabled until June 20<sup>th</sup> meeting.

# Township Committee Reports and Correspondences:

Mr. Ryan stated the following:

The initial purpose of the Salt Trust was to build a reserve of \$40,000 to \$50,000 with the intent to cover any potential excessive costs the municipality experiences due to a winter season that requires a more than average use of salt and grit.

The Committee established this trust via Resolution 2016-30 in February 2016.

Once the Trust reaches the \$40,000 to \$50,000 then the Committee will decide if the annual funding of \$10,000 will be continued or reapplied to the streets and roads – (#10529020) other expenses or buildings and grounds – other expenses (#10531020) live items.

Withdrawal of money from the Salt Trust is only with the notice and approval of the committee.

On motion by Mr. Ryan, seconded by Mayor Nyland and passed unanimously on roll call vote to approve the Salt Trust stipulations.

Mr. Ryan asked that when the Clerk is out of the office, all three Committee members be notified by mail or e-mail if the office is to be closed for an extended period of time. Also, if any closures are known or planned ahead, that it be posted on the website a week in advance. Mr. Ryan asked that the Clerk have the meeting minutes typed and sent to the Committee no more than two weeks after a meeting.

Mr. Ort added that this might not be possible if the Clerk is out of the office.

Mr. Ort stated he was in Kentucky with the Oxford Archery Team. He said that the team did very well and are the State Champions again, twelfth year in a row. Mr. Ort stated it was very cool to see over 15,000 shooters in one place.

Mr. Magnuson said that the Archery Team finished in the top thirty percent.

Mr. Magnuson stated that he will update the years on the Archery sign and is trying to get magnetic (year) signs to be put on the sign.
