

**WORKSHOP MEETING  
JULY 1, 2019**

A Workshop Meeting of the Township Committee of Oxford Township was held on July 1, 2019 in the Oxford Township Municipal Building, 11 Green Street, Oxford, New Jersey.

In attendance were Gerald Norton, Robert Nyland, Committee Members, Richard Wenner, Attorney and Sheila L. Oberly, Municipal Clerk.

The flag salute was recited.

Deputy Mayor Nyland called the meeting to order at 6:02 PM.

On motion by Mr. Nyland and seconded by Mr. Norton to authorize Lou Accetturo to hire a Part-time Laborer to the Department of Public Works Department.

Mr. Nyland asked Ms. Oberly to write a letter to Russ Semeran,-CEO of GreenLife New Jersey LLC stating that the Oxford Township Committee would like to welcome him and Greenlife to Oxford Township and let them know Oxford is very supportive of Greenlife New Jersey, LLC.

Mr. Norton stated that at the School Board meeting, there will be a discussion about the referendum that will be on the November ballot for residents to vote, yes or no. The State of New Jersey will fund 46% of the cost and the taxpayers will fund 54%.

The Committee gave permission to The Oxford Fire Department to use the T-ball field on August 18<sup>th</sup> in order to hold the "Oxford Field Truck" event.

Mr. Norton will e-mail Rich Motyka, Tax Assessor to ask him for a "rough" estimate of the value of Cambridge West, property.

On motion by Mr. Norton and passed unanimously on roll call vote to pay the bills approved at the meeting.

Mrs. Hissim stated that the seniors held their July meeting at the Oxford Furnace Lake and the bathrooms were disgusting.

Eddy Patient, Lake Director addressed the issue.
