Meeting Minutes:

Georgette Miller moved to accept the February 16, 2022 regular meeting and Executive Session minutes. Seconded by Linda Koufodontes. Ayes: 3, Nays: 0, Abstain: 0. Absent: 0. Motion passed. Georgette Miller moved to accept the March 2, 2022 regular meeting minutes. Seconded by Linda Koufodontes. Ayes: 2, Nays: 0, Abstain: 1. Absent: 0. Motion passed

Public Comment on Agenda items: - Margaret Bray, Residents and business owners on Wall Street are not in favor of Ordinance 2022-03 Prohibiting parking on Wall Street as it would impact the customers, many of whom are elderly. Discussion covered, but was not limited to, handicapped parking, safety issues, accidents, parking in rear lot, a stop sign, reducing the speed limit, no left turn out of Allen, and marking out parking spots. Mayor Norton stated since the town has been notified of potential risks and has received many complaints, they are obliged to address the situation. He will meet with residents and business owners to discuss the issue further.

Ordinance 2022-04 COLA

ORDINANCE 2022-04 CALENDAR YEAR 2022

MODEL ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Governing Body of the Township of Oxford in the County of Warren finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township of Oxford hereby determines that a 1.0 % increase in the budget for said year, amounting to \$ 11,788.04 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Township of Oxford hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Governing Body of the Township of Oxford, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Township of Oxford shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$41,258.14, and that the CY 2022 municipal budget for the Township of Oxford be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Ordinance 2022-05 Sewer fees range

ORDINANCE 2022-05

ORDINANCE OF THE TOWNSHIP OF OXFORD, COUNTY OF WARREN AND STATE OF NEW JERSEY AMENDING CHAPTER 260, SEWERS, SECTION 17, ANNUAL USER FEE, OF THE CODE OF THE TOWNSHIP OF OXFORD IN ORDER TO ESTABLISH A RANGE OF \$700 TO \$1500 PER EDU

BE IT ORDAINED by the Township Committee that Chapter 260, *Sewers*, Section 17, *Annual User Fee*, subsection C is deleted in its entirety and replaced as follows: 260-17(C) User charge per EDU.

The annual user charge per equivalent dwelling unit (EDU) for users in both Oxford Township and Washington Township shall be within a range of \$700 to \$1500. The Township Committee shall, on an annual basis, adopt a resolution setting the specific charge per EDU for that year for users within Oxford Township and shall also establish the specific charge per EDU for users within Washington Township.

Section 2: Severability

Any article, section, paragraph, subsection, clause, or other provision of the Code of the Township of Oxford inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency

Section 3: Repealer

If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

Section 4: Effective Date

This ordinance shall take effect after final passage and publication as provided by law.

Ordinance 2022-06 Garbage fees range

ORDINANCE 2022-06

ORDINANCE OF THE TOWNSHIP OF OXFORD, COUNTY OF WARREN AND STATE OF NEW JERSEY AMENDING CHAPTER 280, SOLID WASTE; RECYCLING, SECTION 3, COLLECTION AND FEES, OF THE CODE OF THE TOWNSHIP OF OXFORD IN ORDER TO ESTABLISH AN ANNUAL RANGE OF \$200 TO \$500

BE IT ORDAINED by the Township Committee that Chapter 280, *Solid Waste; Recycling*, Section 3, *Collection and Fees*, subsection C is deleted in its entirety and replaced as follows: 280-3(C). Fees.

Each occupant, which term shall not include churches, Oxford public school, Oxford Fire Department or Oxford Emergency Squad as that term is defined herein, from whom garbage, refuse or rubbish is collected by the Township of Oxford, shall pay to the Township the following sums for solid waste removal:

1) The annual range for fees for solid waste collection for both residential and commercial (per dumpster/per occurrence) shall be \$200 to \$500. The specific fee for residential and commercial users shall be established annually by resolution of the Mayor and Committee.

Section 2: Severability

Any article, section, paragraph, subsection, clause, or other provision of the Code of the Township of Oxford inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency

Section 3: Repealer

If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

Section 4: Effective Date

This ordinance shall take effect after final passage and publication as provided by law.

AN ORDINANCE OF THE TOWNSHIP OF OXFORD, COUNTY OF WARREN AND STATE OF NEW JERSEY AMENDING CHAPTER 91, VEHICLES AND TRAFFIC, SECTION 41,

SCHEDULE XIII, PARKING PROHIBITED AT ALL TIMES, TO INCLUDE WALL STREET BETWEEN WASHINGTON AVENUE AND ALLEN AVENUE

Section 1:

BE IT ORDAINED, by the Township Committee of the Township of Oxford, County of Warren and State of New Jersey, that Chapter 91, *Vehicles and Traffic*, Section 41, Schedule XIII, *Parking Prohibited at All Times*, is hereby amended by adding the eastbound section of Wall Street between Washington Avenue and Allen Avenue consisting of +/- 220 linear feet.

BE IT FURTHER ORDAINED that in addition to the penalty provision set forth in §91-2 of the Code, any vehicle parked in violation of Chapter 91, Section 41 shall be subject to towing by the appropriate enforcing agency.

Section 2: Severability

Any article, section, paragraph, subsection, clause, or other provision of the Code of the Township of Oxford inconsistent with the provisions of this ordinance is hereby repealed to the extent of such inconsistency

Section 3: Repealer

If any section, paragraph, subsection, clause, or provision of this ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall apply only to section, paragraph, subsection, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

Section 4: Effective Date

This ordinance shall take effect after final passage and publication as provided by law

Resolution 2022-28 Redevelopment Investigation Authorization Cambridge West RESOLUTION 2022-28

RESOLUTION AUTHORIZING AND DIRECTING THE LAND USE BOARD OF THE TOWNSHIP OF OXFORD TO UNDERTAKE A PRELIMINARY INVESTIGATION TO DETERMINE WHETHER A CERTAIN AREA WITHIN THE TOWNSHIP CONSTITUTES A "CONDEMNATION AREA IN NEED OF REDEVELOPMENT"

WHEREAS, pursuant to N.J.S.A. 40A:12A-6, the governing body of the Township of Oxford ("Township") is authorized to direct the Land Use Board of the Township of Oxford ("Land Use Board") to undertake a preliminary investigation in order to determine whether a certain area within the Township would qualify as condemnation area in need of redevelopment pursuant to the criteria set forth in N.J.S.A. 40A:12A-5; and

WHEREAS, the Legislature amended the Local Redevelopment and Housing Law on September 6, 2013 to expand and clarify various provisions of same; and

WHEREAS, as a provision of the amendment to N.J.S.A. 40A:12-6, the Legislature has directed that the resolution authorizing the planning board to undertake a preliminary investigation shall state whether the redevelopment area determination shall authorize the municipality to use all those powers provided by the Legislature for use in a redevelopment area other than the use of eminent domain ("Non-Condemnation Redevelopment Area") or whether the redevelopment area determination shall authorize the municipality

to use all those powers provided by the Legislature for use in a redevelopment area, including the powers of eminent domain ("Condemnation Redevelopment Area"); and

WHEREAS, the Township of Oxford intends to use all the powers provided by the Legislature for use in a redevelopment area, and specifically, the Township of Oxford may utilize the power of eminent domain; and

WHEREAS, the Township Committee desires the Land Use Board to conduct such a preliminary investigation relative to certain properties located within the Township, more specifically identified as Block 26, Lots 80, 80.01, 84.01 and 84.02, Block 27, Lots 127, 137, 141, 142, 143, 144, 145, 146, 147 and 148, Block 28, Lots 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 17 and 26 and Block 29, Lots 1, 2, 3, 4, 7, 8, 9, 10, 11, 12, 14, 16, 18, 21, 22, 28 and 36 as shown on the Official Tax Map of the Township of Oxford (the "Properties"); and

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Oxford, they being the Governing Body thereof, as follows:

- 1. The Land Use Board of the Township of Oxford is hereby directed to conduct a preliminary investigation to determine whether the aforementioned properties, or any portions thereof, constitute a condemnation area in need of redevelopment according to the criteria set forth in N.J.S.A. 40A:12A-5;
- 2. The Land Use Board of the Township of Oxford is hereby directed to conduct a preliminary investigation of the aforementioned Property, in accordance with the requirements set forth in NJ.S.A. 40A: 12A-6, more specifically, to prepare a map showing the boundaries of the potential condemnation area in need of redevelopment and locations of the various parcels of property included therein, with a statement setting forth the basis for the investigation appended to the map; to specify a date for a public hearing for the purpose of hearing persons who are interested in, or would be affected by, the determination that the delineated area is a condemnation area in need of redevelopment; to give notice of said hearing pursuant to the hearing notice requirements set forth in N.J.S.A. 40A:12A-6(b)(3); to hear and receive into the record any objections to such a determination that the proposed property be designated an area in need of redevelopment; and
- 3. After completing its hearing on the matter, the Land Use Board shall recommend that the delineated area, or any part thereof, be determined, or not be determined, by the Municipal Governing Body to be a condemnation area in need of redevelopment.

BE FURTHER IT RESOLVED that this resolution shall take effect immediately.

- <u>- In Rem Foreclosure 45 Bush Street</u> Mayor Norton received a call from an appraiser looking at 45 Bush Street. He told the caller about the demolition order and liens on the property. Rich Wenner will review the dates of the In Rem Foreclosure proceedings to determine when it will be finalized.

<u>- Lake passes for PTA Tricky Tray</u> – Georgette Miller asked Susan Turner to print Family and Day passes sent by the Lake Director for the Oxford Central PTA Tricky Tray fundraiser.

Township Committee Reports and Correspondence

-Linda Koufodontes attended the Board of Education meeting in person on March 10, 2022. The budget was reviewed. There was a 5.4% (\$167,000) decrease in state funds. The curriculum has been added back to the website and the website is now ADA compliant.

Township Administrator – Matt Hall stated he has met with Officer Pantuso regarding code violations.

<u>Township Engineer Report</u> – Mike Finelli stated the last of the work to be done in Spring Meadow is scheduled for the end of them month. JCP&L replaced the light pole. Donna Becker reviewed the Kent Street project and made changes that bring the cost down to \$149,000. The grant is \$141,000. Mike distributed a breakdown of expected costs and stated some of the items are not co-op and will have to go to bid. This could result in higher costs than expected. Mayor Norton moved to authorize Mike Finelli's firm to move forward with the Kent Street project. Seconded by Linda Koufodontes. Ayes: 3, Nays: 0, Abstain:0, Absent:0. Motion approved.

Mike stated he was notified today that the third round of HDSRF funds were approved. He will have more information tomorrow.
