Mr. Dolan opted to do a Variance application. There are 3 variances with his application 1, Front Yard setback, 2, Height and 3, Square Footage. Mr. Finelli deemed the variance application complete and Mr. Dolan will notice for hearing for May 23, 2023. Mr. Niece and Mr. Norton both had the same question about their large loft area.
