Ordinance 2024-10 – this was presented before and we need to make some revisions to the ordinance. Tim O'Brian went thru the report and it is not inconsistent with our Master Plan. Mike Finelli asked Tim O'Brian about 3 and 4 stories stated that 3 stories 35 ft and 4 stories up to 50st in the TC 4 zone.

Mr. Ort made a motion that Ordinance 2024-10 is not inconsistent with the master plan and there a reno further recommendations. Seconded by Mr. Neice.
