ORDINANCE OF THE TOWNSHIP OF OXFORD, COUNTY OF WARREN, STATE OF NEW JERSEY AMENDING CHAPTER 91-43 *SCHEDULE XV: PARKING PROHIBITED DURING CERTAIN HOURS* OF THE TOWNSHIP CODE IN ORDER TO ADD NO PARKING DURING CERTAIN HOURS ALONG THE NORTH SIDE OF KENT STREET AND AMENDING CHAPTER 91-33 *SCHEDULE V. PROHIBITED TURNS AT INTERSECTIONS* TO ADD NO LEFT TURN PROHIBITIONS AT CERTAIN CHURCH STREET INTERSECTIONS

BE IT ORDAINED by the Township Committee of the Township of Oxford that:

Chapter 91-43, *Schedule XV: Parking Prohibited During Certain Hours* of the Code of the Township of Oxford is hereby amended to delete the existing Kent Street parking prohibition and replace with the following:

Kent Street (North Side)	All Vehicles	7:30a.m. –9: 30a.m. Monday-Friday 2:00p.m. – 4:00p.m. Monday-Friday
Church Street at Kent (extending along the easterly curbline of Church for approximately 128 feet)	All Vehicles	7:30a.m. –9: 30a.m. Monday-Friday 2:00p.m. – 4:00p.m. Monday-Friday

Chapter 91-33, *Schedule V; Prohibited Turns at Intersections* of the Code of the Township of Oxford is hereby amended to add the following prohibited turns at certain Church Street intersections:

Church Street	All Vehicles	Left Turn on Kent Street	7:30a.m. –9: 30a.m. Mon-Fri 2:00p.m. – 4:00p.m. Mon-Fri
Municipal Lot (across from OCS)	All Vehicles	Left Turn on Kent Street	7:30a.m. -9:30 a.m. Mon-Fri 2:00p.m. – 4:00p.m. Mon-Fri

Section 2:

Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 3:

Repealer. Any ordinance or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 4:

Effective Date. This Ordinance shall take effect upon final passage and publication as provided by law.
